#### **WELCOMING REMARKS**

Michigan Avenue Branch Manager Katie Dover-Taylor addressed the group with a warm welcome to the newly reopened facilities. She provided an overview of the events and emotions surrounding the reopening among the community, patrons and staff. She also thanked the Board for their support, hard work, and leadership to make the reopened facility a reality.

#### PRESENTATION OF 2024 ANNUAL REPORT

Community Relations Coordinator Sam Killian began his presentation with several anecdotes regarding the reopening of Michigan Avenue. He then segued into an overview of the 2024 Annual Report which focused on the repair and renovation of Michigan Avenue while highlighting the many accomplishments achieved despite the difficulties amid the closure of the branch. He pointed out some of the improvements to specific areas at both Superior and Whittaker locations as well as strategic initiatives accomplished in the year. He also addressed the strengthening of grants, donations and strategic partnerships that allowed the library to expand a number of services and programs that impact the community. Next, he provided an overview of some of the many letters and social media posts of support and appreciation from the community. Finally, he closed with some percentages and statistics regarding library use, as well as a financial report for the year.

#### **COMMUNICATION**

Director Hoenig first highlighted the notification from YpsiWrites regarding "A Great Day in Ypsi" with a photo opportunity for writers of all ages happening at Michigan Avenue from 1-3 p.m. on May 3, 2025. She also touched upon the Washtenaw County Community Mental Health news release that lists the grants issued to non-profits, including the one issued to the library for the social work initiative supporting case management and programming to serve some of Ypsilanti's most vulnerable populations. She also mentioned the blog from Senior Resource Connect called the Spotlight which focused on the Outreach Department and bookmobile led by, Monica Porter. Director Hoenig ended this section by pointing out an article that discusses how the recent spate of funding cuts is impacting projects and grants, including some indirectly affecting YDL.

#### **COMMITTEE REPORTS**

Facilities – Director Hoenig spoke about the anticipated completion of "the river" at the Michigan Avenue Library Plaza scheduled for completion this Friday, April 18<sup>th</sup>. She also advised that the new hot water recirculation pump at Michigan Avenue has been installed and is working correctly, with just a few small finishing tasks to be completed this week by the contractor.

Michigan Avenue Building – Director Hoenig let the Board know the most recent construction meeting was cancelled due to illnesses with the contractors and architect, but that the final completion schedule for the vestibule will be determined soon. The remaining punch list items will be completed in the next couple of weeks. The vestibule may take longer, but the facility will remain open during that time.

Personnel – Trustee Steimel deferred this to New Business C.

#### REPORT OF THE LIBRARY DIRECTOR

Director Hoenig advised the Board that the library is planning an Open House at Michigan Avenue the first Friday in June, when the City of Ypsilanti holds their First Friday events. The building would stay open past normal operating hours to accommodate this. The following morning is the Summer Challenge Kick-Off, which will also be held at Michigan Avenue and has some additional opening events planned. She also asked if the Board would be interested in a ribbon cutting to celebrate the re-opening on June 6<sup>th</sup>. Director Hoenig let the Board know about a recent grant awarded from the Ann Arbor Rotary Club to fully fund a program that will support reading initiatives at the Michigan Avenue branch from June 2025 to February 2026. She also briefly spoke about the Summer of HeART, which is also fully funded now, and how this program originally was just at the Superior branch but now will also be at the Michigan Avenue branch.

C. Discussion of draft from for staff input on the evaluation of the Director

Trustee Steimel provided an overview to the Board regarding the recent discussions held by the Personnel Committee in regards to processes, procedures and deadlines to solicit staff input for the Director's evaluation. A discussion was held among the Trustees and Director, and the group refined the process, stressing anonymity for the staff and how the data will be used.

D. Potential Board statement regarding Institute of Museum and Library Services federal funding

Trustee Maddix proposed that the Board provide a statement regarding federal funding. She read a draft and the trustees discussed and refined a finalized version for adoption, which follows here:

The Ypsilanti District Library Board of Trustees would like to voice its opposition to the Executive Order signed by President Trump on March 14, 2025. This order eliminates the Institute of Museum and Library Services (IMLS), the federal agency responsible for distributing congressionally appropriated funds to state libraries.

IMLS funding is crucial for resource sharing, technology upgrades, staff training, and various library programs. While the loss of IMLS funding negatively impacts these services at Ypsilanti District Library, it will be devastating to many rural libraries, forcing some to even shut down. We ask that Michigan lawmakers and library lovers across the country advocate for continued IMLS funding to ensure libraries remain havens for intellectual freedom, socialization, and learning.

The Ypsilanti District Library Board of Trustees stands with Michigan libraries and museums, as well as those across the country. If you wish to stand with us in supporting our libraries, see below for steps you can take.
